

GROUPE ROCHER TESTS THE SECURITY OF ITS MOBILE APPLICATIONS WITH PRADEO SECURITY

Groupe Rocher, owner of Yves Rocher and Petit Bateau among other brands, has dozens of corporate and public mobile applications that globally combine more than 1 million users.

As a guarantee of quality and in order to ensure the safety of its various users, the group systematically audits its applications before they are distributed. This way, the development team identifies their security flaws and remedies them.

Since 2014, Groupe Rocher's Chief Information Security Officer has been using the Pradeo Security Mobile Application Security Testing solution. He shares his experience.

LEGAL, FINANCIAL AND REPUTATION RISKS

Governments require companies to protect the personal and financial data of their users. Mobile applications are directly affected by these regulations due to the confidential nature of the information they access.

Mobile e-commerce applications are vulnerable to fraud. A recent study by the RSA Fraud and Risk Intelligence team shows that in the first quarter of 2020, the volume of fraudulent transactions originating from mobile applications has doubled.

The leakage of private data is punishable by law, but is also a source of bad press. Companies that have experienced such crises have seen their image damaged.

"For all of our mobile applications, the main risk is reputational. For business applications, there are also risks related to user privacy and financial transactions. We therefore had to be able to guarantee the quality and security of the code developed."

To date, the Groupe Rocher has tested the security of some **sixty Android and iOS mobile applications** via the Pradeo Security online platform. These audits have enabled the development team to identify and correct unexpected behaviours that they did not want their applications to perform, and to identify coding practices that were making them vulnerable to attacks. The remediation advice provided by the tool facilitated security patching.
